# 1) Approve previous meeting minutes

- October 17<sup>th</sup>, 2020. Pat moves to approve with correction listed below. Ed seconds. No abstentions, none opposing. **Approved.** 
  - America Walk grant: correct amount \$1,500 instead of \$15,000

## 2) Cornell Park

- Dan D: Deed transferred to BTC about three weeks ago. Dan D sent a copy to FWP Land Conservation Specialist Mimi Wolok – she wanted a title search so Dan D. asked Sara Bennett Welborn for one. The estimated cost for the title will be about \$160. Trout Unlimited might be able to help cover that cost, Dan D offered to donate the rest.
- We are now in a position to lead restoration work with our partners. Zach and volunteers have placed wire fencing around trees for protection against beavers.
- Joyce and Larry put up signs indicating that BTC is now assuming liability for the park. Zach stated intention to meet with FWP hopes to finalize design and budget. Dan & Zach will arrange meeting w/FWP. Zach also wants to reach to landowners around the park.
- Possible funding sources:
  - Land and Water Conservation Funds (LWCF) administered by MT State Parks (state and local projects portion of it). Needs a match. (Beaverhead Watershed Committee)
  - There is also a program of appropriations called "Future Fisheries" w/cycle starting 6/1/21. Significant resources available. Need a design in place. (Trout Unlimited)
  - Steele Reese fall 2021 (BTC)
  - Kiwanis has a foundation that might be able to contribute funds.

#### Received:

• **Bench Memorial:** Katherine Barnett, daughter of Torborg Haga Hoyland, bench location on Tim's Ridge.

Joyce ordered bracket welding from Bill Macoronal – Mike and Joyce Connors will buy decking material and assemble the bench. Once it's done, we'll organize its installation on the trail. Bench cost around \$350.

### Applied:

- **State Farm 2020**: Ed and Kathleen submitted an application at the end of Oct. They asked for \$8,000 for the Noble Ave construction. We should know by end of first quarter.
- Clif Bar: Applied for \$10,000 for Noble Ave. We should know by Feb. 1
- America Walks Community Grant: Applied Ed and Kathleen applied for Noble Ave. Worth \$1,500. They will be emailing all applicants directly by December 2020.
- **Town & Country Foods:** They will allow us to have donation boxes at their cash registers during the holidays.

#### Others:

- RTP Stewardship Match Grant Program (MT State Park): Due Feb 1, Ed started application. For \$22,000 (\$28,000 needed).
- **Union Pacific** funding cycle begins typically in April-May for application submission, and funding announced by Sept. Apply for Noble for \$5,000

- United Way: opens 12/1/20 app due 1/31/21. Let's ask Kathleen to apply for \$2,000 for Noble.
- **Steele Reese:** opens Dec 1 for Noble \$5,000. We need to have letter of intent in by 12/1/20.
- BCBS: This one typically opens in early January. We have yet to get it, but I can apply again.
  BOD's need to discuss and let me know. Cornell for stream bank restoration. Dan D will help.
- **Giving Tuesday:** Let's focus on Noble Avenue this year. Online (Facebook) fundraiser on December 1<sup>st</sup>. BOD + members go live on FB and do challenges as we reach milestone amounts.

**Cornell Park:** funding search now for park restoration, stream rehabilitation, landscaping funding. So far I have a short list of grants to apply for, but they do not open until early next year or Spring. This includes AARP, VF Foundation, Quadratic, Rumphius Foundation, and a few others I'm still researching. I will keep looking.
